EARLY CHILDHOOD LEARNING AT LCA:

a home away from home

For over 35 years, children as young as six weeks old have found their home away from home on LCA's campus. What began as Holy Family Learning Center has now become Lakewood Catholic Academy's Early Childhood Program where children develop the skills necessary to be lifelong learners.

Five years ago, we combined all early childhood programs under the direction of a designated early childhood administrative team. This change has had a positive impact within our program, resulting in a 20% enrollment increase and a fully enrolled center. The retention rate of children in the Early Childhood Program continuing on to kindergarten has increased from 15% to over 85%, which proves that when families enroll their children at LCA, many of them intend to remain with the community through the primary and middle years. Families are not only drawn to LCA because of the high-quality education and faith-based community, but because it is a place where they can bring their infants and school age children to learn and grow together.

Due in part to the support of the greater LCA community, we have been able to retain dynamic and talented staff that have been here for many years. Our average tenure for lead teachers is 15 years and 5 years for assistant teachers. Although the pandemic of 2020 brought about closures, high staff turnover rates and lack of staff throughout early childhood programs across the nation, LCA has been able to thrive and become more vibrant now than ever. We continue to hire and recruit exceptional teachers, offering bonuses, competitive salaries, ongoing recognition, high quality professional development, faculty meal plans, tuition benefits and ongoing support of the whole person. We invest in our staff because they have the largest impact on the success of our program.

As we continue to grow and expand, so do the programs and resources. We offer ongoing support to families through our Parent Support Series. In addition, we look for ways to engage families to allow them opportunities to be involved in their child's education and within the LCA community. Our program has adopted and implemented Creative Curriculum, Conscious Discipline and Heggerty that is aligned to the early learning standards and promotes learning and development in each of the following areas: social, emotional, physical, language, and cognitive. We believe in developing the whole child here at LCA because






